Vivre says —with obvious pride!— on her Wikipedia web site that she regularly changes the wording and rewrites articles dealing with gay and lesbian issuesIt is dangerous for your credibility to have political activists slanting articles to fit their own political objectivesNARTH must have the right to post corrections to an article about itself without having a lesbian activist vandalize the site by reposting inaccurate or distorted statements about the history and goals of NARTHWe insist that Vivre be prohibited from making future changes on the NARTH site — and that whatever corrections NARTH chooses to post on the site will remain there without being deleted by other anti-NARTH activists.
